Including CCF in your Estate Plan may enable you to make a contribution that might otherwise not be feasible; it costs you nothing today and ensures support for our mission in the future.



Choose the type of bequest that is right for you:

- ❖ A Specific or General Bequest: *Specify a specific asset or amount of money.*
- ❖ A Percentage Bequest: *Specify a percentage of your estate assets.*
- ❖ A Residuary Bequest: *Specify a portion of the residual amount that is left in your estate after all specific bequests have been satisfied.*

Benefits of making a gift to CCF through your estate:

- ❖ Including CCF in your estate plan ensures support for CCF beyond your own lifetime.
- ❖ Almost any kind of asset can be given, including cash, securities, personal property, and/or land.
- ❖ A charitable gift from your estate is deductible for federal tax purposes, with no limit on the amount of the deduction. It is also generally not subject to state inheritance or estate taxes.*

Sample language to include in your will: "I hereby give and bequeath to Carlisle Conservation Foundation, Inc., a non-profit corporation organized and existing under the laws of the Commonwealth of Massachusetts, _____ dollars (\$____) [or __ percent (__%) or all of the rest, residue, and remainder of my estate] to be applied to the general uses and purposes of said organization."
